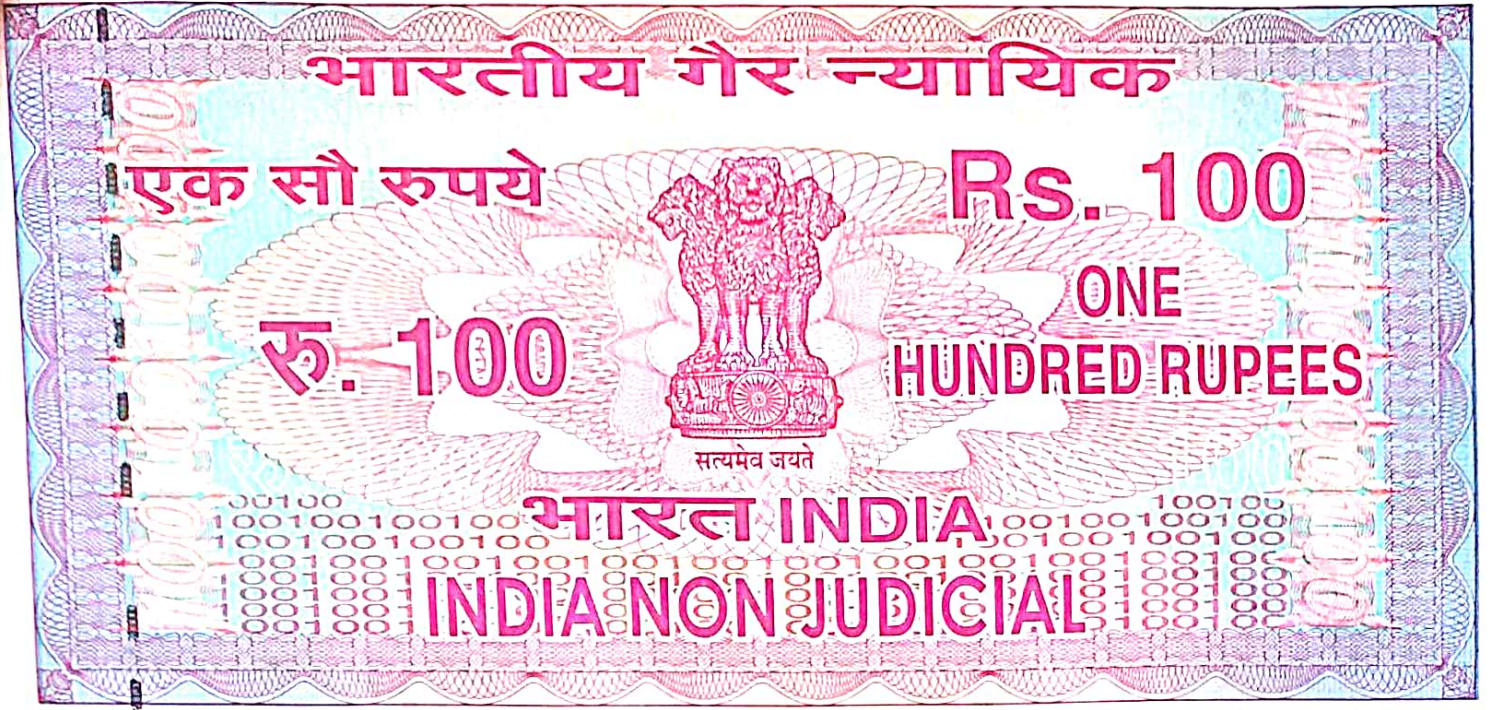

This Memorandum of Understanding (hereinafter called as the 'MoU') is entered into on this the 20<sup>th</sup> day of the Month April 2017, by and between Meenakshi Chandrasekaran College of Arts & Science, Karambayam, Pattukkottai, Thanjavur (Dt), Tamil Nadu, the First Party represented herein by its Principal and Sri Bharathi Arts and Science College For Women Kaikurichi, Pudukkottai (Dt), Tamil Nadu, the Second Party, and represented herein by its Principal.

WHEREAS:

- A) First Party is a Higher Educational Institution named: **Meenakshi Chandrasekaran College of Arts & Science, Karambayam, Pattukkottai, Thanjavur(Dt), Tamil Nadu,**
- B) Second Party is a Higher Educational Institution named: **Sri Bharathi Arts and Science College For Women Kaikurichi, Pudukkottai (Dt), Tamil Nadu.**
- C) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MoU, THE PARTIES HERETO AGREE AS FOLLOWS:

**CLAUSE 1: CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.

**CLAUSE 2: SCOPE OF THE MoU**

- 2.1. Both parties agree to encourage the following exchange activities based on their respective academic and education needs.
- I. Collaborative research and Joint Research Programs
  - II. Exchange of information on research and education programs.
  - III. Exchange visits by faculty, researchers and students (visit & in plant training, to carry out their projects mutually with research facilities).
  - IV. Joint proposals and engagement in research and training programs sponsored by funding agencies



- V. Participate joint and exchange the academic council development programs.
- VI. Joint Conferences and Joint Online events
- VII. Other academically beneficial events as may be agreed to by both the parties from time to time.
- VIII. Joint prominently with workshop and seminar.
- IX. Exchange and sharing the Guest Lecturer Programs.
- X. Joint and share the utilization of laboratory and library.

2.2. The implementation of each exchange program referred above will follow the guidelines established on mutual agreement by both the parties. Efforts will be made by both the parties to find financial resources for carrying out the activities listed above.

2.3. Nothing shall diminish the full autonomy of either institution nor will any constraints be imposed by either upon the other in carrying out the agreement.

2.4 There is no financial commitment on both the Parties to take up any program / activities mentioned in the scope of MoU/ co-operation mentioned in this MoU. If there is any financial consideration, it will be dealt separately.

2.5 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required.

### CLAUSE 3: VALIDITY

3.1 The agreement shall be in force for a period of THREE YEARS from the date of the last signing and is subject to revision or modification by mutual consent. It is also understood that this agreement may serve as the basis for the specific agreements to be developed at later date. It is further understood that either institution may terminate the agreement at any time, upon one year written notification to the partner institution, although such action will only be taken after mutual consultation in order to avoid any possible inconvenience to either party.
